## **Refund Roster**

A refund roster is required for every refund sent to SFA to identify the student for whom the money is being returned, the term for which the money is being returned, the fund/program for which the money was awarded, the refund amount, and the refund reason.

Reports may be submitted in any of the three acceptable formats, including Microsoft Excel, ASCII Delimited Text (comma delimited with text strings in "), and Fixed-length ASCII text.

Tables are provided below for the Refund Report Layout, the Fund Codes and Refund Reason Codes.
