DUAL ENROLLMENT/CREDIT SCHOLARSHIP 2024-2025

Mississippi resident Junior or Senior in public or charter high school Meet criteria for participation in dual enrollment/credit Enroll in eligible academic or CTE dual enrollment/credit course

> **AWARD AMOUNT:** Tuition for up to six (6) credit hours

APPLY for DEDC SCHOLARSHIP

Application Opens April 1, 2024

STUDENT ELIGIBILITY REQUIREMENTS:

- Mississippi resident
- Junior or senior in public/charter high school in MS
- Meet criteria in *Procedures Manual for the State of Mississippi Dual Enrollment and Accelerated Programs* (high school counselors must ensure students meet all requirements)
- Enroll in eligible academic or CTE course (course must be listed in *Procedures Manual*)

APPLICATION PROCESS:

- Student applies at msfinancialaid.org. The application for DEDC is separate from the application a student submits for state aid after high school graduation. The application is short, with fields for:
 - o Demographics
 - o Contact information
 - High school, classification, & expected graduation date
 - College or university attending (by term)
- Students are not required to submit supporting documents.
- Upon submitting the application, students should verify their email address to ensure they are able to log in to their MAAPP account.
- The student will use the same MAAPP account throughout their high school and college careers.

AWARD AMOUNT AND PROCESS:

- DEDC will cover the tuition costs for up to 6 credit hours (lifetime maximum) of dual enrollment/credit.
- Tuition for DEDC recipients will be reimbursed to the college at a set rate of 40% of the average community college credit hour tuition. For 2023-24, the rate was \$65.08/credit hour. The 2024-25 rate will be published late summer 2024.
- DEDC awards are equal to the set-rate tuition for up to six credit hours (typically two courses, either academic or CTE).
- Funds will be awarded on a first-come, first-served basis. As long as funds remain available, students will be offered a tentative award shortly after submitting the application.
- Awards will be paid directly to the college offering the dual enrollment/credit course only after the student's enrollment has been confirmed.

DEADLINES:

- Fall 2024 October 15, 2024
- Spring 2025 March 15, 2025
- Summer 2025 March 15, 2025 (update institution through June 1, 2025)
